**October 1, 2019** - NO organization meeting is scheduled for Women's B. Please contact either league rep to arrange packet drop off by due date.

- Turn in registration forms (team roster with individual membership applications for NEW players) and payment by CHECK ONLY (no more than two, payable to "Honolulu Tennis League" and each subject to a \$10.00 assessment if returned by the bank). Discussion to follow
- There is no guarantee that the late team entries will be accepted but, if accepted, a \$25.00 fee may be charged

**October 15, 2019** - Ranking Committee meets (each league will meet on their own).

NO CHANGES can be made to the team rosters once they are accepted, except to replace players who are injured, reranked or rejected by the Ranking Committee or as otherwise approved by the Ranking Committee.

**October 22, 2019** - Team Captains will be informed of any ranking changes

**November 5, 2019** Appeals may be made to the Appeals Referee in WRITING by - email [uedoig@gmail.com](mailto:uedoig@gmail.com).

**November 12, 2019** - A binding decision will be rendered

**November 19, 2019** - Any replacements for re-ranked or rejected players must be submitted to the League Reps

**December 3, 2019** - Team rosters, approved rankings, match schedule, playoff format, and any other information to be emailed and posted

**December 1-31, 2019** – Each League will advise on Ball pick up procedure

**January 5, 2020 First Day of Match Play** - to continue for approximately 13 weeks, including playoffs.
